PRESIDENT'S MESSAGE



I am pleased to introduce the 2015 report for the Chinese Medicine Council. The information marks the third such report for this Council under the National Accreditation and Registration Scheme.

Chinese Medicine practitioners may be registered in one or more of three divisions: acupuncture, Chinese herbal medicine and Chinese herbal dispensing.

The primary responsibility of the Council, in conjunction with the Health Care Complaints Commission, is to protect the public by managing performance, conduct and health concerns relating to Chinese Medicine practitioners and students in NSW.

Over the past year, there was a 50% increase in complaints rising from eight in 2013/14 to 12 in the 2014/15 period. This report provides more detail about the nature of these complaints.

The HPCA continues to provide the Chinese Medicine Council with effective, efficient and professional support to help it perform its regulatory and legislative functions. This support facilitates the Council in fulfilling its public protection charter, which includes ensuring that Chinese Medicine practitioners practise in a safe and ethical manner.

Finally, I would like to thank Ms Karen Thomas, the Council's outgoing Community Member, for her valued contribution to the Council's deliberations over the past three years and welcome Mr Stephen Woods, who has been appointed in the Community Member role for a three-year term.

The Chinese Medicine Council will continue to maintain our responsibility in protecting the public and I look forward to contributing to this task in the coming year.



COMPLAINTS

This year 12 new complaints were received about 12 NSW Chinese Medicine practitioners representing 0.7% of NSW practitioners. This is 50% more than the number of complaints received in 2013/14



Regulation of Chinese Medicine practitioners in NSW in 2014/15

Year in summary

NSW has 1,820 registered Chinese Medicine practitioners which is 4.8% more than the 1,737 practitioners registered last year and 40.5% of the 4,494 Chinese Medicine practitioners registered to practise in Australia.

This year 12 new complaints were received about 12 NSW Chinese Medicine practitioners representing 0.7% of NSW registered Chinese Medicine practitioners. This is 50% more than the number of complaints received about NSW registered Chinese Medicine practitioners in 2013/14.

Complaints about NSW Chinese Medicine practitioners included:

- 4 related to conduct 33.3%
- 7 related to performance 58.4%
- 1 related to health/impairment 8.3%.

One mandatory notification was received.

Four complaints were received from patients, two from an insurance company and one each from a relative, Police, another health practitioner, AHPRA, the public and an anonymous source.

A total of 14 complaints were managed during the reporting period, including two carried over from 2013/14.

Two complaints were immediate action matters, one involved health assessment and one involved an Impaired Registrants Panel.

Six practitioners were monitored for compliance with orders/conditions in the reporting period.

Ten complaints were closed during the year with outcomes including:

- 1 referred to another body
- 1 out of jurisdiction to act
- 1 required no further action after assessment
- 1 withdrawn
- 6 discontinued.

Remuneration for members of the Council was as follows.

In addition, Council members receive sitting fees of \$448 per day and \$218 per half day for the conduct of Council Inquiries and \$256 per day and \$128 per half day for attendance at committee meetings and other regulatory activities, if held on a day other than the monthly Council meeting. Council members are reimbursed for expenses incurred when travelling on official business at Council direction.

Members of panels and Tribunals also receive remuneration and reimbursement of expenses.
